

National Report from Alan Pollard, Chief Executive, 11/05/2023

CCNZ remains mindful of the significant financial commitment that members make to join Civil Contractors NZ, and the expectation that we will deliver significant member and industry value. We take that obligation seriously. The team are committed to working in members best interests to try and ensure an operating environment that supports business success.

The value that CCNZ can add is evident in a number of ways:

Financial

The financial statements for National Office for the year ended 31 March 2023 are still being finalised. We currently expect a surplus of just over \$100,000, largely due to a higher Contrafed dividend and a healthy surplus from the 2022 conference.

The National Office balance sheet is healthy, with net equity at almost \$1.8m including cash and term investments of \$1,100,000.
